If the Beneficiary Account Number you provide above does not match the Beneficiary Name, we shall still remit the funds to the designated Beneficiary Account Number and neither we nor the Receiving Bank shall be liable for failing to reconcile any such discrepancy in your Request instructions. As part of our security procedures, we may verify that you authorized this Request by telephoning you to confirm that you initiated it. We will not be liable for our refusal to honor, or a delay in honoring, any Request if we are unable to satisfy ourselves that you made the Request. Further, you agree that if we process your Request, we do so without responsibility for any loss or delay, error or delay in transmission of messages by you or with respect to the transfer itself, whether due to automated encryption systems or telex; any acts or omissions of the correspondent banks or other agencies involved in the transfer of funds or for any cause beyond the control of the Bank, all of which risks are assumed by you.

The Bank provides wire transfer services in accordance with and you agree to abide by applicable laws and regulations, including but not limited to, the U.S. Treasury’s Office of Foreign Assets Control (OFAC). The Bank is obligated to block and hold the proceeds of any transactions where any party is included on one of OFAC’s lists of designates until such entity is removed from the list or upon receipt of permission to release from OFAC.

By signing below, you confirm to the Bank that you understand and agree that: (i) this Request is subject to the terms of the Wire Agreement; (ii) the security procedures utilized to process this Request are commercially reasonable; and (iii) we may reject any transfer in our sole discretion.
